- To be used when both distributing bike helmets and implementing a bike rodeo

I understand and agree that the sole purpose of this program is to help reduce the incidence of death and injury as a result of bicycle crashes. I understand and agree that the Safe Kids _____ (hereinafter "Coalition") and Safe Kids Worldwide (hereinafter "SKW") are providing this bicycle safety rodeo program as a free service to me, and the Coalition and SKW are providing me with a free bicycle helmet as a public service in the interest of safety and helping to prevent injury to children.

I further agree to hold harmless any and all organization and individual participants in the above referenced program from and against all damages of any kind, to persons or property, resulting from the education program and the distribution of bicycle helmets.

I understand that the Coalition and SKW do not guarantee or endorse this brand of bicycle helmets and that neither is a seller, manufacturer or dealer of the helmet itself. I understand I must follow the manufacturer instructions for proper fit of the bicycle helmet for my child and will ensure my child wears a bike helmet every time he/she rides.

I understand and agree that:

- ▶ the sole purpose of this program is to help increase bike helmet use
- ▶ the bike helmet is provided as a public service in the interest of encouraging safety
- ▶ for the helmet to be effective it must fit properly and be used following manufacturer's instructions
- ▶ the helmet is to be used for bike riding and may not provide proper protection when used during other activities
- ▶ it is extremely dangerous for my child to wear a helmet other than when bicycling, such as when climbing and on playgrounds
